Course Approval Requirements:

In order to be eligible for State Bar approval, the program must:

- a. be of significant intellectual and/or practical content for bail bond professionals,
- b. cover topics of criminal law and procedure or bail bond law,
- c. be a minimum of <u>1.00</u> hour in length,
- d. include quality paper(s) (course materials) prepared and distributed by <u>each</u> speaker at the course
- e. <u>not</u> be eligible for MCLE accreditation, and
- f. be an institution of higher education as defined by the Texas Education Code. An institution of higher education means any public technical institute, public junior college, public senior college or university, medical or dental unit, public state college or other agency of higher education as defined in Section 61.003 of the Texas Education Code.
