### Purpose

Your essay can be based on a single occurrence or on a lifetime of professionalism.

### Award Guidelines

Two award recipients will be chosen from all of the Law Student Division applicants. You **must** be an active Law Student Division member to apply.

The judges will use the following criteria when evaluating each essay:

Interpretation of the Theme	50%
Writing Style	25%
Clarity	10%
Grammatical Mechanics	15%

### Eligibility Rules

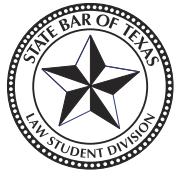
- To be eligible for this award, you **must** be a current member of the State Bar of Texas Law Student Division.
